## **CERTIFICATE OF THE COMPTROLLER AND AUDITOR GENERAL OF INDIA**

This compilation containing the Finance Accounts of the Government of Rajasthan for the year ending 31<sup>st</sup> March 2010 presents the accounts of the receipts and disbursements of the Government for the year, together with the financial results disclosed by the revenue and capital accounts, the accounts of the public debt and the liabilities and assets as worked out from the balances recorded in the accounts. The Appropriation Accounts of the Government for the year for Grants and Charged Appropriations are presented in a separate compilation.

The Finance Accounts have been prepared under my supervision in accordance with the requirements of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 and have been compiled from the vouchers, challans and initial and subsidiary accounts rendered by the treasuries, offices, and departments responsible for the keeping of such accounts functioning under the control of the Government of Rajasthan and the statements received from the Reserve Bank of India. Statements 7(ii), 9 and 14, explanatory notes at point no. 2 under Statement No. 11 and Appendix No. IX and Appendices VII and X in this compilation have been prepared directly from the information received from the Government of Rajasthan who is responsible to ensure the correctness of such information.

The treasuries, offices, and or departments functioning under the control of the Government of Rajasthan are primarily responsible for preparation and correctness of the initial and subsidiary accounts as well as ensuring the regularity of transactions in accordance with the applicable laws, standards, rules and regulations relating to such accounts and transactions. I am responsible for compilation, keeping of the accounts, preparation and submission of Annual Accounts to the State Legislature. My responsibility for the compilation, preparation and finalization of accounts is discharged through the office of the Principal Accountant General (A&E). The audit of these accounts is independently conducted through the office of the Principal Accountant General (Civil Audit) in accordance with the requirements of Articles 149 and 151 of the Constitution of India and the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971, for expressing an opinion on these Accounts based on the results of such audit. These offices are independent organizations with distinct cadres, separate reporting lines and management structure.

The audit was conducted in accordance with the Auditing Standards generally accepted in India. These Standards require that we plan and perform the audit to obtain reasonable assurance that the accounts are free from material misstatement. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements.

On the basis of the information and explanations that my officers required and have obtained, and according to the best of my information as a result of test audit of the accounts and on consideration of explanations given, I certify that, to the best of my knowledge and belief, the Finance Accounts read with the explanatory 'Notes to Accounts' give a true and fair view of the receipts and disbursements for the purpose of the Government of Rajasthan for the year 2009-10.

Points of interest arising from study of these accounts as well as test audit conducted during the year or earlier years are contained in my Reports on the Government of Rajasthan being presented separately for the year ended 31<sup>st</sup> March 2010.

# GUIDE TO THE FINANCE ACCOUNTS

## A. BROAD OVERVIEW OF THE STRUCTURE OF GOVERNMENT ACCOUNTS

### 1. The Accounts of the Government are kept in three parts:

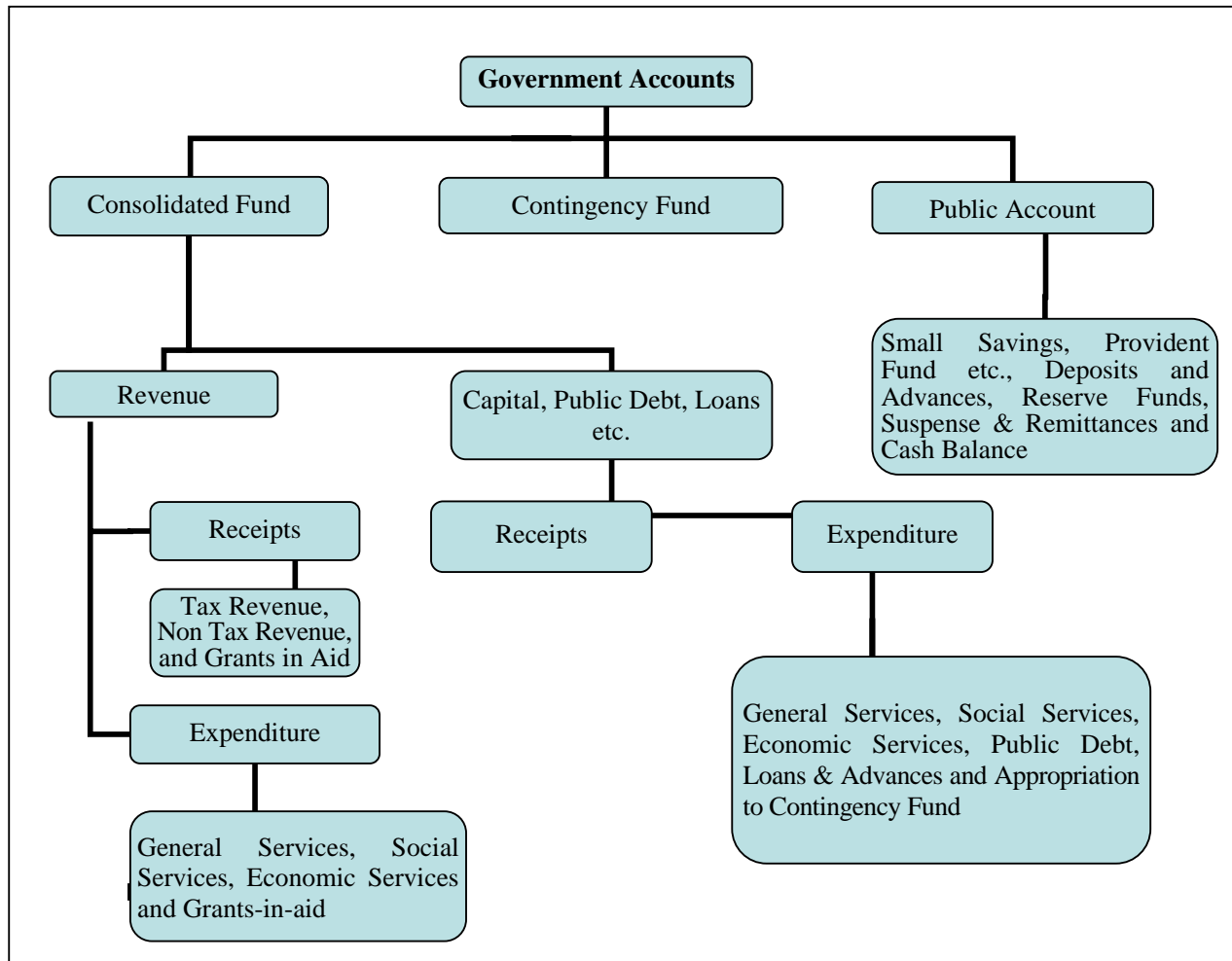
**Part I: The Consolidated Fund:** All Receipts and Expenditure on Revenue and Capital Account, Public Debt and Loans & Advances forms the Consolidated Fund of the State

**Part II: The Contingency Fund:** Legislature may by law establish a Contingency Fund, which is in the nature of an imprest. The Fund is placed at the disposal of the Governor to enable advances to be made for meeting unforeseen expenditure on a scheme/object of expenditure, not provided for in the Budget. The fund is recouped by debiting the expenditure to the concerned functional major head in the Consolidated Fund of the State before the closure of accounts of the year.

**Part III: The Public Account:** All other public moneys received by or on behalf of the Government are credited to the Public Account. The receipts and expenditure out of this account are not subject to the vote of the Legislature. In respect of the receipts into this account, the Government acts as a banker or trustee. Transactions relating to Debt, Deposits, Advances, Reserve Funds, Remittances and Suspense form the Public Account.

## 2. Divisions, Sections, Sectors etc

The two main divisions of the Accounts in the Consolidated fund are, as depicted in A.1.1 on previous page, 'Revenue and 'Capital' which are divided into sections 'Receipts 'and 'Expenditure'. Within each of the Divisions and Sections of the Consolidated Fund the transactions are grouped into Sectors such as, "General Services", "Social Services", "Economic Services", under which specific functions or services shall be grouped. The Sectors are sub-divided into sub sectors/ Major heads of account. Major heads correspond to functions and are further divided into sub major heads (sub functions) and minor heads (programmes), which are depicted in Volume 2 of the Finance Accounts. The classification below minor heads of account i.e. subheads (schemes) and detailed and object heads (objects of expenditure) are not depicted in the Finance Accounts, though some details are included in the appendices.

## **B. WHAT DO THE STATEMENTS CONTAIN**

The Finance Accounts have been divided into two volumes. Volume 1 presents the financial statements of the Government in the form of commonly understood summarised form while the details are presented in volume 2.

**Volume 1** contains the Certificate of the Comptroller and Auditor General of India, four summary statements as given below and Notes to Accounts including accounting policy.

- 1. Statement of Financial Position:** Cumulative figures of assets and liabilities of the Government, as they stand at the end of the year, are depicted in the statement. The assets are largely financial assets with the figures for progressive capital expenditure denoting physical assets of the Government. Assets, as per the accounting policy, are depicted at historical cost.
- 2. Statement of Receipts and Disbursements:** This is a summarised statement showing all receipts and disbursements of the Government during the year in all the three parts in which Government account is kept, namely, the consolidated fund, contingency fund and public account. Further within the consolidated fund, receipts and expenditure on revenue and capital account are depicted distinctly.

The fiscal parameters of the Government, i.e. the primary, revenue and fiscal deficit are calculated on the operations of the consolidated fund of the State. Hence the following two statements give the operations of the consolidated fund in a summarised form.

- 3. Statement of Receipts in Consolidated Fund:** This statement comprises revenue and capital receipts and receipts from borrowings of the Government consisting of loans from the Government of India and market loans raised by the Government.
- 4. Statement of Expenditure in Consolidated Fund:** This statement not only gives expenditure by function (activity) but also summarises expenditure by nature of activity (objects of expenditure).

The second volume comprises three parts. The **first part contains six statements** as given below:

- 5. Statement of Progressive Capital Expenditure:** This statement details progressive capital expenditure by functions, the aggregate of which is depicted in statement 1.

- 6. Statement of Borrowings and other Liabilities:** Borrowings of the Government comprise market loans raised by it (internal debt) and Loans and Advances received from the GOI. Both these together form the public debt of the State Government. In addition, this summary statement depicts 'other liabilities' which are the balances under various sectors in the public account. In respect of the latter, the Government acts as a trustee or custodian of the funds, hence these constitute liabilities of the Government. The statement also contains a note on service of debt, i.e a note on the quantum of net interest charges met from revenue receipts.
- 7. Statement of Loans and Advances given by the Government:** The loans and advances given by the State Government are depicted in Statement 1 and recoveries, disbursements feature in Statements 2,3 and 4. Here, loans and advances are summarised sector and loanee group wise. This is followed by a note on the recoveries in arrear in respect of loans, the details of which are maintained by the Pr. Accountant General (A&E) Office and details of which are maintained by the State departments.
- 8. Statement of Grants-in-aid given by the Government:** This Statement presents details of Grants-in-aid given by the State Government, organised by grantee institutions group wise. It includes a note on grants given in kind also.
- 9. Statement of Guarantees given by the Government:** Guarantees given by the State Government for repayment of loans, etc. raised by Statutory Corporations, Government Companies, Local Bodies and Other institutions during the year and sums guaranteed outstanding as at the end of the year are presented in his statement.
- 10. Statement of Voted and Charged Expenditure:** This statement presents details of voted and charged expenditure of the Government.
- Volume 2 Part II:** This part contains **9 Statements** presenting details of transactions by **minor head** corresponding to statements in volume 1 and part 1 of volume 2.
- 11. Detailed Statement of Revenue and Capital Receipts by minor heads:** This statement presents the revenue and capital receipts of the Government in detail.
- 12. Detailed Statement of Revenue Expenditure by minor heads:** This statement presents the details of revenue expenditure of the Government in detail. Non Plan, Plan and Centrally Sponsored Schemes (CSS) figures are depicted separately and a comparison with the figures for the previous year are available.
- 13. Detailed Statement of Capital Expenditure:** This statement presents the details of capital expenditure of the Government in detail. Non Plan, Plan and Centrally Sponsored Schemes (CSS) figures are depicted separately and a comparison with the figures for the previous year are available. Cumulative capital expenditure upto the end of the year is also depicted.
- 14. Detailed Statement of Investments of the Government:** The position of Government Investment in the share capital and debentures of different concerns is depicted in this statement for the current and previous year. Details include type of shares held, face value, dividend received etc.
- 15. Detailed Statement of Borrowings and other Liabilities:** Details of borrowings (market loans raised by the Government and Loans etc from GOI) by minor heads, the maturity and repayment profile of all loans is provided in this statement. This is the detailed statement corresponding to statement 6 in Part I Volume 2.
- 16. Detailed Statement on Loans and Advances given by the Government:** The details of loans and advances given by the Government, the changes in loan balances, loans written off, interest received on loans etc. is presented in this statement. It also presents plan loans separately. This is the detailed statement corresponding to statement 7 in Part I Volume 2.

**17. Detailed Statement on Sources and Application of funds for expenditure other than Revenue Account:** The capital and other expenditure (other than on revenue account and the sources of fund for the expenditure is depicted in this statement.

**18. Detailed Statement on Contingency Fund and other Public Account transactions:** The statement shows changes in contingency fund during the year, the appropriations to the fund, expenditure, amount recouped etc. It also depicts the transactions in public account in detail.

**19. Detailed Statement on Investments of earmarked funds:** This statement shows the details of investment out of reserve funds in public account.

**Volume 2 Part III contains Appendices** on salaries, subsidies, grants-in-aid scheme wise and institution wise, details of externally aided projects, scheme wise expenditure in respect of major Central schemes and State Plan schemes etc. These details are present in the accounts at sub head level or below (i.e. below minor head levels) and so are not depicted in the Finance accounts. For a detail list please refer to the index in volume 1 or 2. The Statements read with the appendices give a complete picture of the state of finances prevailing in the State Government.

- (iii) Annual adjustment of interest on GPF and State Government Group Insurance Scheme where interest on General Provident Fund of State Government is adjusted by debiting 2049-Interest and crediting 8009-General Provident Fund.

## NOTES TO ACCOUNTS

### 1. Summary of significant accounting policies

- (i) **Entity and Accounting Period:** These accounts present the transactions of the Government of Rajasthan for the period 1<sup>st</sup> April 2009 to 31<sup>st</sup> March 2010.
- (ii) **Basis of Accounting:** The accounts represent the actual cash receipts and disbursements during the accounting period (with the exception of some book adjustments, note below). Assets are valued at historical cost and Government investment is also shown at historical cost. Physical assets are not depreciated or amortised. The losses of physical assets at the end of its life is also not expensed or recognised.

The pension liability of the Government, i.e. the liability towards payment of retirement benefits for the past and the present service of its employees is not included in the accounts. However, the retirement benefits disbursed during the accounting period have been reflected under Major Head 2071 in Statement No. 12.

The expenditure on "pension and other retirement benefits" to State Government employees during the year was ₹ 48,86.84 crore (12.18% of total revenue expenditure). However, the State Government has switched over to the new pension scheme w.e.f. 01-01-2004. An amount of ₹ 2,47.75 crore towards employee's contribution has been deposited under the head '8011-106(03) New Contributory Pension Scheme for Government Employees' during the year. The State Government liability on this account as on 31<sup>st</sup> March 2010 was ₹ 6,75.48 crore.

- (iii) **Currency in which Accounts are kept:** The accounts of Government are maintained in Indian Rupees ₹.
- (iv) **Form of Accounts:** Under Article 150 of the Constitution, the accounts of the Union and of the States are kept in such a form as the President may on the advice of the Comptroller and Auditor General, prescribes. The word "Form" used in Article 150 has a comprehensive meaning so as to include the prescription not only of the broad form in which the accounts are to be kept but also the basis for selecting appropriate heads under which the transactions are to be classified.
- (v) **Classification between Revenue and Capital:** Revenue expenditure is of recurring nature and is to be met from the revenue receipts. Capital Expenditure is defined as expenditure incurred with the object of increasing concrete assets, which are of a material and permanent character. Expenditure on Grants-in-Aid is recorded as revenue expenditure in the books of the grantor. In the books of the recipient, it is taken as a revenue receipt.

**3. Debt Relief**

In order to maintain the fiscal discipline required for macro- economic stability, the Government of India, on the recommendations of the Twelfth Finance Commission and as per the guidelines of the Debt Consolidation and Relief Facility (DCRF) decided to reschedule the repayment of total outstanding central loans into 20 annual instalments. It was further announced that debt waiver of such instalment would be sanctioned if the State Government maintained its fiscal deficit upto 3% of Gross State Domestic Product (GSDP). Consequently, the State Government also introduced the FRBM Act, 2005 w.e.f. 03-05-2005 and the Government of India consolidated the entire Central Loan of ₹ 61,74.08 crore outstanding in the account of Rajasthan as on 31-03-2004 and rescheduled the repayment of such loan into 20 instalments of ₹ 3,08.70 crore each. The Government of India further relaxed the above condition and allowed the State to keep its fiscal deficit upto 3.5% and 4% during the years 2008-09 and 2009-10 respectively. In view of fiscal deficit being maintained earlier, the Government of India provisionally released the debt relief for the year 2008-09, but due to inability of the State Government in covering the fiscal deficit within 3.5% of GSDP in 2008-09 the Government of India directed the RBI to recover the instalment of ₹ 3,08.70 crore from the State Account in 2009-10. Further, in 2009-10 also the Debt Relief was not sanctioned by the Government of India as the State Government once again failed to maintain the fiscal deficit within 4% of GSDP due to which the State Government had to make a payment of its debt instalment.

Therefore, due to non-fulfilment of above conditions by the State Government for two years consecutively they had to suffer an additional overburden of ₹ 6,17.40 crore.

## NOTES TO ACCOUNTS - (Contd.)

### 4. Booking under Minor Head 800- 'Other Expenditure' and 'Other Receipts'

₹ 39,90.03 crore under 55 Major Heads of accounts (representing functions of the Government) were classified under the Minor Head '800- Other Expenditure' in the accounts constituting more than 8.80 percent of the total expenditure (Revenue and Capital) recorded under the respective Major Heads. The details of such significant expenditure of more than 20 percent under the respective head are at **Annex-A** to this **Notes to Accounts**. The major schemes such as 'Rajasthan Investment Promotion Policy', 'National Rural Health Mission', 'Mission for livelihood', 'Crop Compensation', 'National Agriculture Development Project' and 'Devnarain Yojana' etc. which have large amount booked under the Minor Head 800, are not depicted distinctly in the Finance Accounts, though the details of these expenditure are depicted at the sub-head (Scheme) level or below in the Detailed Demands for Grants and corresponding headwise Appropriation Accounts forming part of the State Government accounts.

Similarly, ₹ 41,24.64 crore under 43 Major Heads of accounts (representing functions of the Government) were classified under the Minor Head '800- Other Receipts' in the accounts constituting more than 11.65 percent of the total receipts recorded under the respective Major Heads. The details of such significant receipt of more than 20 percent under the respective head are at **Annex-A** to this **Notes to Accounts**.

### 5. Transfer of Funds to Personal Deposit Accounts (PD Accounts)

Government is authorized to open P. D. Accounts in order to deposit money by transferring funds from the Consolidated Fund for discharging liabilities of the Government arising out of special enactments, the Administrators are required to close such accounts on the last working day of the year and transfer the unspent balances back to the Government Accounts (Consolidated Fund) and the P. D. Accounts need to be opened next year again if necessary. Transfer of funds to P. D. Accounts is booked as expenditure in the Consolidated Fund (service Major Heads) of the State. In the year 2009-10, ₹ 60,09.53 crore have been transferred to P. D. Accounts, of which ₹ 9,93.84 crore (16.54%) were transferred in March 2010 alone. Besides, 43 P. D. Accounts involving ₹ 4.67 crore remained inoperative for the last five years i.e. from 2005-06 to 2009-10 not yielding any interest. The aggregate amount of the unspent balances in the accounts of the Administrators, which are not credited back to Government Account, is not readily ascertainable as such funds also include receipts from source other than the Consolidated Fund of State.

### 6. Existence of unadjusted Abstract Contingent Bills (AC Bills)

The Drawing and Disbursing Officers are authorized to draw sums of money for sudden and emergent purposes by preparing Abstract Contingent Bill (A C Bills) by debiting Service Heads and they are required to submit the Detailed Contingent Bill (vouchers in support of final expenditure) in all these cases to the Pr. Accountant General (A&E) through treasuries at the earliest possible. Presently, 1000 DC Bills amounting to ₹ 3,17.69 crore have yet not been received in the office of the Pr. Accountant General (A&E) (August 2010), as detailed below :-

### 7. Reconciliation of Receipt and Expenditure

As per the provisions of financial code, all Controlling Officers are required to reconcile the receipt and expenditure figures of the Government with the figures accounted for by the Pr. Accountant General (A&E). Such a reconciliation has been completed 100 percent by all the 361 Controlling Officers for the total expenditure of ₹ 4,87,49.81 crore.

Similarly, out of 141 Controlling Officers, 115 have reconciled Government receipts to the extent of 96.56 percent i.e. ₹ 3,41,78.09 crore against the total receipts (including Capital Receipt) of ₹ 3,53,93.95 crore for the year 2009-10.

### 8. Book Adjustment

Certain transactions are in the nature of periodical adjustments and book adjustments and do not represent actual cash transaction, as mentioned below. The specific details are mentioned as 'Notes to Accounts' and as footnotes in the relevant statements.

- (i) Creation of Funds/ adjustment of contribution to Funds in Public Account by debit to Consolidated Fund e.g. Calamity Relief Fund, Reserve Funds etc.
- (ii) Crediting of deposit heads of accounts in Public Account by debit to Consolidated Fund
- (iii) Annual adjustment of interest on General Provident Fund and State Government Group Insurance Scheme where interest on General Provident Fund of State Government is adjusted by debiting 2049- Interest Payments and crediting 8009- State Provident Funds

A statement of Periodical and Other Book Adjustments is enclosed as an **Annex-B** to this **Notes to Accounts**.

### 9. Cash Balance

Cash Balance- Deposit with Reserve Bank of India is required to be regularly reconciled with the cash balance of the State Government. Accordingly cash balance (deposits with RBI) worked out by Pr. Accountant General was ₹ 5,73.41 crore (credit). The cash balance reported by RBI as on 31 March 2010 was ₹ 5,74.04 crore (debit). The difference of ₹ 63,18,904 (credit) between the two figures was mainly on account of wrong reporting of figures by some banks to the RBI, Jaipur. However, the difference amounting to ₹ 63,18,904 has been identified and taken into account during the next accounting period i.e. (2010-11).

## NOTES TO ACCOUNTS - (Contd.)

### 10. Advances from Contingency Fund

The State Government has taken ₹ 5.38 crore as advances from Contingency Fund under 3 Major heads during the year. All the advances taken from the Fund during the year have been recouped as such no amount remained unrecouped as on 31 March 2010.

### 11. Utilization Certificates for Grants-in-aid

Rules provide that for the grants provided for specific purposes, Utilization Certificates (UCs) should be obtained by the departmental officers from the grantees and after verification, these should be forwarded to the Pr. Accountant General within 12 months from the date of their sanction unless specified otherwise. However, till 2009-10 (June 2010) Utilization Certificates amounting to ₹ 23.02 crore were yet to be received, the break-up of last three years is as below :-

### 12. Guarantees given by the State Government

Guarantees reported in Statement No. 9 are on the basis of the information received from the State Government, which is the real authority for issue of such Guarantees. The guarantees constitute contingent liability on the revenues of the State. In case of any contingency arising on account of discharge of the State's obligation on invoking of guarantees the same has to be met out of the Guarantee Redemption Fund.

### 13. Reserve Fund

- (i) **Rajasthan Development and Poverty Alleviation Fund:** The Government of Rajasthan, in the year 2007 created the "Rajasthan Development and Poverty Alleviation Fund" by amending the Rajasthan Fiscal Responsibility and Budget Management Act, 2005 with an object of using such accumulations in the years of fiscal distress and for poverty alleviation and development purposes. In this Fund the tax receipts of the State Government comprising of its own taxes and share in Central taxes in any year in excess of 17.5% over the previous year was to be credited in the ensuing year. This Fund was to be utilised by the State Government (i) for meeting revenue and capital expenditure if the growth of revenue collection is less than 10% over the previous year and (ii) to meet the expenditure incurred on development programmes or for poverty alleviation programme. The State Government transferred ₹ 8,50.96 crore to this Fund i.e. ₹ 1,00.00 crore in 2006-07, ₹ 5,31.75 crore in 2007-08 and ₹ 2,19.21 crore in 2008-09 by debiting to Major Head 3451.

However, in 2009-10, the State Government has written back the entire accumulated amount of three years totalling to ₹ 8,50.96 crore from Fund and deposited to Revenue Receipt.

## NOTES TO ACCOUNTS - (Contd.)

### 13. Reserve Fund - (Concl.)

- (ii) **Guarantee Redemption Fund:** The State Government set up the Guarantee Redemption Fund in 1999-2000 by transferring the guarantee fees to this Fund every year. During 2009-10 the State Government received ₹ 36.94 crore as guarantee fees. Besides, a balance of ₹ 11.00 crore pertaining to the previous years was also lying there. Therefore, the total amount of Guarantee Fees i.e. ₹ 47.94 crore (₹ 36.94 crore + ₹ 11.00 crore) had to be transferred to the Fund during 2009-10, but the State Government transferred only ₹ 11.00 crore to this Fund during 2009-10 and hence the revenue deficit of the State Government was reduced by ₹ 36.94 crore.

As on 31<sup>st</sup> March 2010 a balance of ₹ 1,57.73 crore (₹ 1,50.48 crore Guarantee Fees and ₹ 7.25 crore interest received on investment of said Fund) was lying under Guarantee Redemption Fund. No amount has been reimbursed from this Fund in respect of guarantees.

- (iii) **Rajasthan State Investment Fund:** The Government of Rajasthan has constituted the Rajasthan State Investment Fund w.e.f. 26-02-2007 with an initial corpus of ₹ 77.65 crore with the object of buy back and resale of Rajasthan State Development Bonds. During 2007-08 the State Government transferred a huge amount of ₹ 9,00.00 crore from the State Consolidated Fund by debiting to Major head 4047 (Capital Outlay on Fiscal Services) in view of better financial position and to avoid the lapse of funds as conveyed by the State Government. However, the fund was not utilised for buy back and resale of Rajasthan State Development Bonds. Subsequently, the State Government transferred ₹ 2,12.00 crore and ₹ 6,88.00 crore in 2008-09 and 2009-10 respectively to the Consolidated Fund (Capital head) to meet the additional financial burden due to application of recommendations of Sixth Pay Commission and impact of continuous recession on the State Fiscal position.
- (iv) **Other Funds:** In addition to above there are 25 other Funds out of which 16 are active. The total accumulated balance as at the end of 31 March 2010 in these Funds was ₹ 7,79.79 crore. During the year an amount of ₹ 12,61.15 crore was transferred as contribution to these Funds. The total expenditure shown as met out from these Funds was ₹ 14,94.22 crore.

### 14. Loans and Advances and Government Investment

In respect of Loans for which detailed accounts are kept by the State Government departments, the complete information regarding arrears of recoveries of loans and interest thereon has been received from State Authorities only in 90 statements out of 186 statements.

As regards the details of investment, the efforts were made to obtain complete information of Government investment made in the Public Sector Undertaking etc. but the entire information has not been received till finalisation of the Finance Accounts.

### 15. Suspense and Remittances

The Finance Accounts reflect the net balances under Suspense and Remittance Heads. The outstanding balances under these heads are worked out by aggregating the outstanding debit and credit balances separately under various heads. The position of gross figures under major suspense heads for the last three years is given below :

**16. Funds transferred to Autonomous Bodies etc.**

The State Government provides funds to State/ district level autonomous bodies and authorities, societies, non-governmental organizations, etc. for implementation of centrally sponsored schemes and State schemes. Since the funds are generally not being spent fully by the implementing agencies in the same financial year, there remain unspent balances in the bank accounts of these implementing agencies.

The aggregate amount of the unspent balances in the accounts of the implementing agencies kept outside Government accounts (in bank accounts) is not readily ascertainable. The Government expenditure as reflected in the Accounts to that extent is, therefore, not final.

## APPENDIX No. I - (Contd.)

### Explanatory Notes

- (a) **Daily Cash Balance:** Under an agreement with the Reserve Bank of India, the State Government has to maintain a minimum cash balance of ₹ 2.34 crore with the Bank on all the days w.e.f. 01-03-1999. If the balance falls below the agreed minimum on any day, the deficiency is made good by taking ordinary and special ways and means advances/ overdrafts from time to time.

For arriving at the daily cash balance for the purpose of grant of Ways and Means advances/ Overdraft, the Reserve Bank of India evaluates the holdings of the 14 days Treasury Bills along with the transactions reported (at RBI counters, Inter-Government transactions and Treasury transactions reported by the agency banks) for the day. To the cash balance so arrived, the maturity of 14 days Treasury Bills if any, is added and excess balance, if any, after maintaining the minimum cash balance is reinvested in Treasury Bills. **If the net cash balance arrived at results in less than the minimum cash balance** or a credit balance and if there are no 14 days Treasury Bills maturing on that day, RBI rediscounts the holdings of the 14 days Treasury Bills and makes good the shortfall. If there is no holding of 14 days Treasury Bills on that day the State Government applies for Ways and Means Advances/ Special Ways and Means Advances/ Overdraft.

- (b) The limit for Normal Ways and Means Advances to the State Government was ₹ 5,05.00 crore w.e.f. 01-04-2006. The Bank has also agreed to give Special Ways and Means Advances against the pledge of Government Securities. The limit of Special Ways and Means Advances is revised by the Bank from time to time.

The rate of interest as Bank Rate had been charged on Ways & Means Advances and Overdrafts up to 31st March 2006. The Repo Rate was introduced w.e.f. 1st April, 2006 as against Bank Rate. The Repo Rate was 5 percent w.e.f. 4th March 2009, it was further revised in 2009-10 i.e. 4.75 percent w.e.f. 21st April 2009 and

5 percent w.e.f. 20th March 2010. The same was prevailed upto 31st March, 2010.

As regards Normal Ways & Means Advances, the interest charged upto 90 days equal to Repo Rate and one percent above the Repo Rate for the period beyond 90 days.

The rate of interest applicable on Special Ways & Means Advances has been charged to one percent below the Repo Rate w.e.f 1st April 2006. This is continued till date.

As regards rate of interest on Overdraft upto 100 percent limit of Normal Ways & Means Advances two percent above the Repo Rate and exceeding 100% of Normal Ways & Means Advances, five percent above the Repo Rate.

### **(i) Statement of Public Debt and Other Liabilities - (Concl'd.)**

The State Legislature has passed "The Rajasthan Fiscal Responsibilities and Budget Management Act, 2005" laying down the limits within which State Government may give guarantees on the security of the Consolidated Fund of the State. Under the Act, State Government shall ensure that total outstanding debt, excluding public account, and risk weighted outstanding guarantees in a year shall not exceed twice of the estimated receipts in the Consolidated Fund of the State at the close of the financial year. The total of the debt and risk weighted outstanding guarantees to the extent of ₹ 7,52,03.41 crore against the double of the estimated receipt under consolidated fund amounting to ₹ 9,22,99.85 crore as on 31<sup>st</sup> March 2010 which was within limit.

### **EXPLANATORY NOTES**

#### **1. Amortisation arrangements -**

(a) *Open market loans* - No arrangement exists at present.

(b) *Jagir bonds and loans from Government of India* - No arrangement for amortisation has been made for these bonds and loans.

**2. Loans from Small Saving Fund** - Loans out of the collection in the 'Small Savings Schemes' and 'Public Provident Fund' in the Post offices are being shared between the State Government and the Central Government in the ratio of 3:1. A separate fund viz. 'National Small Savings Fund' was created in 1999-2000 for the purpose of release of loans out of Small Savings collections. The loans received during 2009-10 amounted to ₹ 1,44.11 crore and ₹ 7,03.55 crore were repaid during the year. The balance outstanding at the end of the year was amounting to ₹ 2,32,09.46 crore which was 35.92 percent of the total Public Debt of the State Government as on 31 March 2010.

**3. Loans and Advances from the Central Government - Decrease in indebtedness** - The balance of Loans and Advances from the Central Government was decreased during 2009-10 by ₹ 1,42.28 crore mainly due to less receipt of loans from Central Government.

The loans from the Central Government as on 31<sup>st</sup> March 2010 constituted 11.57 percent of the total Public Debt of the State Government on that date.

**4. Internal Debt of the State Government - Market Loans bearing interest** - These cover long term loans raised in the open market and bonds issued in payment of compensation and rehabilitation grants to ex-jagirdars which are repayable in fifteen years.

Fifteen loans of ₹ 75,00.00 crore were raised during 2009-10. These loans bear interest in range of 7.44 to 8.35 percent and redeemable at par w.e.f. 2019 and 2020 as shown in Annexure to Statement No. 15.

Details of loans raised by Government and outstanding as on 31st March 2010 is given in the Annexure to Statement No. 15. The outstanding balance of market loans was 47.37 percent of the total Public Debt of the State Government.

There were no other borrowings of a purely temporary character.

**5. Other Loans** - Loans from the National Bank for Agricultural and Rural Development (₹ 8,50.00 crore) and Loans from National Co-operative Development Corporation (₹ 44.75 crore). These loans form the constituents of borrowings during the year. Particulars of outstanding loans are given in Statement No. 15 and annexure thereto.

**6. Appropriation for reduction or avoidance of Debt** - Sinking Fund is not in existence.

The State Legislature has passed "The Rajasthan Fiscal Responsibilities and Budget Management Act, 2005" laying down the limits within which State Government may give guarantees on the security of the Consolidated Fund of the State. Under the Act, State Government shall ensure that total outstanding debt, excluding public account, and risk weighted outstanding guarantees in a year shall not exceed twice of the estimated receipts in the Consolidated Fund of the State at the close of the financial year. The total of the debt and risk weighted outstanding guarantees to the extent of ₹ 7,52,03.41 crore against the double of the estimated receipt under consolidated fund amounting to ₹ 9,22,99.85 crore as on 31<sup>st</sup> March 2010 which was within limit.

**(B) No guarantee was invoked during the year 2009-10.**

1. The guarantee given to M/s Jaipur Udyog Ltd., Sawai Madhopur was invoked on 30th June 1988 and the State Government was asked to honour the guarantee by paying ₹ 2,74.14 lakh and interest @ 16.5 percent per annum till the date of payment. Accordingly State Government has paid to the Bank a sum of ₹ 2,96,05,871 on 31 March 1995. The company is under liquidation and the case is pending in Court of Law (June 2010).
2. The guarantee given to M/s Jaipur Spinning and Weaving Mills Ltd. Jaipur was invoked on 23rd February 1984 and the Government was asked to honour the guarantee by paying ₹ 5,04.76 lakh and interest @ 18 percent per annum till the date of payment. The case is under trial in Rajasthan High Court. As per court orders an amount of ₹ 5,04.76 lakh was deposited with Debts Recovery Tribunal. To recover amount from the guarantor, case has been filed in Jaipur District Court in April,2003 (June 2010).
3. Against guarantee for ₹ 3,85,00,000 given to various financial institutions/ Banks in favour of M/s Mewar Textiles Mills Ltd., Bhilwara, the State Government had sanctioned a loan of ₹ 3,72,41,451 on 28th January, 2002 to honour the guarantee from which a sum of ₹ 2,07,41,461 had been paid to four financial institutions during the year 2001-02. However, Banks (The Bank of Rajasthan Ltd., Oriental Bank of Commerce and Union Bank of India) have not accepted the amount being paid by the State Government and have gone to the Court of Law for recovery. As per court orders, concurrence was accorded by the Finance Department for payment of an amount of ₹ 15.60 lakh to the Union Bank of India during 2004-05. The case of liquidation of the company is subjudice in Hon'ble High Court, Jodhpur. The appointment of liquidator is yet to be made (June 2010).
4. The guarantee given to Rajasthan State Handloom Development Corporation was invoked during 2003-04 and the State Government was asked to honour the guarantee by paying ₹ 1.80 crore and interest till date of payment. State Government had paid a sum of ₹ 1.08 crore to the Bank of Rajasthan Ltd. during 2003-04 by sanctioning a loan of ₹ 1.08 crore to the Rajasthan State Handloom Development Corporation. No repayment has been made by the Corporation due to its weak financial position (June 2010).

1. *Receipt on revenue account* :- The revenue raised by the State Government during 2009-10 (₹ 2,09,72,49.29 lakh) was more by ₹ 21,40,53.44 lakh than that in 2008-09 (₹ 1,88,31,95.85 lakh) mainly due to more receipts from Taxes on Sales, Trade etc and Corporation Tax, etc. Besides the receipts from Government of India by way of grants and share of net proceeds of certain taxes decreased by ₹ 2,24,37.36 lakh (from ₹ 1,46,36,88.96 lakh in 2008-09 to ₹ 1,44,12,51.60 lakh in 2009-10) mainly due to less receipt of grants from Central Government and share of net proceeds of Customs and Union Excise Duty, etc. Thus, there was an overall increase of ₹ 19,16,16.08 lakh in the total revenue receipts during the year.

**B. Government Account :** Under the system of book-keeping followed in Government accounts, the amount booked under revenue, capital and other transactions of Government the balances of which are not carried forward from year to year in the accounts, are closed to a single head called "Government Account". The balance under this head represents the cumulative result of all such transactions.

To this the balances under Public Debt, Loans and Advances, Small Savings, Provident Funds, Reserve Funds, Deposits and Advances, Suspense and Miscellaneous (Other than Miscellaneous Government Account), Remittances and Contingency Fund, etc. are added and the closing cash balance at the end of the year is to be worked out and proved.

The other headings in the summary take into account the balances under all accounts heads in Government books in regard to which Government has a liability to repay the money received or has a claim to recover the amounts paid and also heads of account opened in the books for adjustment of remittance transactions.

*It must be understood that these balances can not be regarded as a complete record of the financial position of the Government as it does not take into account all the physical assets of the State, such as lands, buildings, communication, etc. nor any accrued dues or outstanding liabilities which are not brought to account under the cash basis of accounting followed by Government.*

2. *Productive and Unproductive Works* - Works in the Water Resources Department are treated as 'Productive' or 'Unproductive' according to whether the net revenue (gross revenue assessed less working expenses) derived from each project on the expiry of ten years from the date of closure of the construction estimates, covers or does not cover the prescribed annual interest charges on the capital invested. The prescribed rate of interest during 2009-10 was 10 percent. If a work treated as 'Productive' fails to yield the prescribed return in three successive years, it is transferred to the 'Unproductive' category. Similarly, if a work treated as 'Unproductive' succeeds in yielding in three successive years the prescribed return, it is transferred to the 'Productive' category. The State Government did not indicate any classification of the works in terms of them being Productive or Unproductive (July 2010).
