



#### PREFATORY REMARKS

An Advance Report for the year 1979-80—Union Government (Civil) was submitted to the President under Article 151 of the Constitution pending submission of the accounts of the Union Government for the year 1979-80. Following finalisation of the accounts of the Union Government for the year 1979-80, this Report has been prepared for submission to the President under Article 151 of the Constitution. It relates mainly to matters arising from the Appropriation Accounts of the Union Government (Civil) for 1979-80 prepared (with a few exceptions) by the Controller General of Accounts and test checked in audit.

The Report also includes in Chapter I certain points of interest arising from the Finance Accounts of the Union Government for 1979-80 under consolidation by the Controller General of Accounts and based on the information furnished by the Controller General of Accounts/Controllers of Accounts.

The cases mentioned in the Report are among those which came to notice in the course of test audit during the year 1979-80 as well as those which came to notice in earlier years but could not be dealt with in the previous Reports.

The points brought out in this Report are not intended to convey or to be understood as conveying any general reflection on the financial administration by the departments/authorities concerned.

Budget estimates for revenue receipts shown above include Rs. 12.65 crores, Rs. 94.87 crores and Rs. 183.77 crores during 1977-78, 1978-79 and 1979-80 respectively being the share of Union Excise Duties payable to States as a result of budget proposals. The figures of budget estimates for expenditure met from revenue shown above do not include these amounts.

Note—The figures for 1979-80 contained in this Chapter are those furnished by the Controller General of Accounts (CGA)/Controllers of Accounts; these could not be verified in audit from the Union Government Finance Accounts for 1979–80 under preparation by the CGA (February 1981) (Prefatory Remarks may also be referred to).

During 1979-80, the revenue receipts and the expenditure met from revenue exceeded the budget estimates by Rs. 80.63 crores and Rs. 746.66 crores respectively. The expenditure on capital account was, however, less than the budget estimates by Rs. 82.88 crores.

During the course of the year, supplementary grants for expenditure were obtained, the effect of which was to increase the above estimates of expenditure met from revenue and expenditure on capital account by Rs. 1154.49 crores and \*Rs. 229.52 crores respectively.

Further details of revenue receipts have been given in the Report on Revenue Receipts.

The increase is mainly due to (i) larger payments to Directorate of Estates for lease of accommodation in New Delhi and for maintenance and repairs of Government buildings and (ii) larger payments of subsidy to Housing and Urban Development Corporation.

The increase is mainly due to (i) larger payments to Akashwani and Doordarshan Commercial Revenues Fund and (ii) payment of commission to advertising agents on account of increase in revenues.

The increase is mainly due to (i) larger expenditure on programmes of education and welfare of the handicapped, women's welfare and family and child welfare, rehabilitation of refugees owing to delay in closure of camps at Tawa project and work sites and post-budget decision to supply rice to the returnee refugee families under Dandakaranya Development Scheme, (ii) inclusion of payments under this head of the Central Government Employee's Insurance Scheme in respect of the Posts and Telegraphs, Railways and Defence Departments and (iii) expenditure on the commission for scheduled castes and scheduled tribes.

The increase is mainly due to (i) larger payments under Fertilizer Retention Price Schemes and Fertilizer Freight Subsidy Scheme, (ii) payment to Oil Industry Development Board against collection of cess, (iii) payment of subsidy to Cotton Corporation of India for import of cotton, (iv) payment to Tea, Coffee, Rubber, Tobacco and Cardamom Boards against cess collection and (v) payment of subsidy for new industrial units in selected backward areas.

The increase is mainly due to (i) larger payments of grantsin-aid and subsidy for interest to Khadi and Village Industries
Commission, (ii) payments for the guarantee of advances to
small scale industries, National Small Industries Corporation,
Handloom industries and Handicraft industries for carpet weaving training centres and training schemes and (iii) larger payment of grants to Central Silk Board for development of silk

The total increase in expenditure under this sector during 1979-80 as compared to 1978-79 is Rs. 160.93 crores. The increase is mainly under the following head:—

The increase is mainly due to larger imports of fertilisers and larger payment on account of increase in its prices abroad and freight and handling charges.

#### (b) Water and Power Development

The total increase in expenditure under this sector during 1979-80 as compared to 1978-79 is Rs. 118.54 crores. The increase is mainly under the following heads:—

The increase is mainly due to larger payments for drainage works in Union Territories of Delhi and Dadra and Nagar Haveli and to Calcutta Port Trust for construction works on Bhagirathi and Hooghly rivers.

The increase is mainly due to (i) larger investments in Badarpur Thermal Power Project and National Thermal Power Corporation and (ii) larger payments on procurement of machinery and equipment for Narora Atomic Power Station.

#### (c) Transport and Communications

The total increase in expenditure under this sector during 1979-80 as compared to 1978-79 is Rs. 19.58 crores. The increase is mainly under the following heads:—

The increase is mainly due to larger payments to International Airport Authority and for development of aerodromes and facilities to cope with the growth in air traffic.

The increase is mainly due to larger payment (i) on maintenance of National Highways and (ii) roads outlays in Union Territories.

Other Transport and Communication Services 8,44 12,46 28,48

The increase is mainly due to larger payments to (i) overseas communication services to cover arrear payment in respect of some equipment for switching programmes at Bombay/New Delhi and unanticipated payments to suppliers for the supply of submerged cable and terminal equipment and (ii) Indian Tourist Development Corporation for meeting the additional hotel accommodation requirements of United Nations Industrial Development Organisation Conference in New Delhi in early 1980.

7. The total investment of Government in Statutory corporations, Government companies, other joint stock companies, cooperative banks and societies, etc. upto March 1980 was Rs. 9385.97\* crores. This amount includes investments in International Bodies like the International Finance Corporation, International Bank for Reconstruction and Development, Asian Development Bank and in Undertakings under construction/expansion from which no dividends are receivable. It also includes investments in nationalised banks, Reserve Bank of India, Life

Against these investments, the amount brought to account during 1979-80 by way of dividend and other receipts was Rs. 78.79 crores and Rs. 230.40 crores respectively. The corresponding receipts in the two preceding years were Rs. 61.29 crores and Rs. 209.50 crores (1978-79) and Rs. 62.79 crores and Rs. 217.17 crores (1977-78) respectively. 15. For loans granted to State Governments for rehabilitation of displaced persons from erstwhile East Pakistan and West Pakistan, State Governments have been paying to Government of India only the amounts actually recovered from displaced persons.

In January 1964, Government decided that the entire loss not exceeding 10 per cent of the total loans advanced to States for rehabilitation of displaced persons from West Pakistan would be borne by the Union Government. In May 1964, it was decided by Government that losses on loans granted up to 31st March 1964 to displaced persons, who migrated from erstwhile East Pakistan up to 31st December 1963, would be borne fully by the Union Government. In March 1965, Government decided to extend these orders to the displaced persons who migrated on or after 1st January 1964. However, in 1975 on the

recommendations of the Sixth Finance Commission all loans for rehabilitation of displaced persons outstanding against each State Government on 31st March 1974 were consolidated and Government decided to bear all the losses on the loans outstanding. The State Governments were also required to repay to the Central Government one-half of the principal of the loans recovered and retain the other-half together with full interest thereon. On repayment of half of the principal, the other-half is sanctioned as grants-in-aid to the State Governments and is not treated as a loss. The Union Government has so far (up to 31st March 1980) remitted or written off (Rs. 29.77 crores) of the loans advanced to States for rehabilitation of displaced persons from East Pakistan.

- 16. During 1979-80, Rs. 261.60 crores were paid as Ways and Means advances to State Governments for clearance/avoidance of overdrafts from the Reserve Bank of India. The entire amount was recovered within that year.

19. Assistance to various countries.—Government of India has been rendering assistance to various countries under the Colombo Plan and Special Commonwealth African Assistance Plan. The aid rendered under the Colombo Plan was Rs. 14.14 crores during 1979-80 and Rs. 165.77 crores up to 1979-80 of which Rs. 157.66 crores were to Nepal (for national highways, hydro-electric projects, minor irrigation works, viliage development programme, training of technical personnel and services

of Indian experts). The aid rendered under the Special Commonwealth African Assistance Plan was Rs. 15.50 lakhs during 1979-80 and Rs. 205.82 lakhs up to the end of 1979-80.

In addition, Government has also given loans to foreign countries; the amount outstanding on that account at the close of 1979-80 was Rs. 270.62 crores.

- 20. Guarantees given by the Union Government.—During 1979-80 Government issued guarantees in 210 cases (including renewal of old guarantees) for Rs. 8390.61 crores. The total amount guaranteed by Government outstanding at the end of 1979-80 was Rs. 7273.00 erores (including certain cases where the sums are payable in foreign currencies). The guarantees were given for loans raised by 102 joint stock companies and Government companies, 6 statutory corporations, 3 port trusts, 5 co-operative banks, 89 co-operative societies, 2 State Financial Corporations, a consumer co-operative society and an autonomous body and Industrial Development Bank. In addition, Government has also guaranteed a minimum dividend on the share capital of certain corporations, as also payment of interest on debentures, etc. floated by them. The following guarantees were invoked during 1979-80 and payments made by Government:—
- (i) Branch line railway companies.—Government has guaranteed a net return of 3½ per cent/5 per cent per annum on the paid up share capital of branch line railway companies. The guarantee was invoked during 1979-80 in the case of three companies and Rs. 15.76 lakhs were paid by Government.
- (ii) Credit guarantees scheme for Small Scale Industries.— During 1979-80, Rs. 332.56 lakhs were paid by Government on account of default in repayment of loans/advances for the guarantees invoked.
- 21. Contributions to International Organisations.—The total amount of contributions to international bodies made during 1979-80 was Rs. 2012.73 lakhs. The more important contributions made during each of the three years ending 1979-80 are indicated below:

The overall saving of Rs. 3181.87 crores represents about 7.2 per cent of the total amount of voted grants and charged appropriations; it was the net result of savings of Rs. 556.74 crores in 135 grants/appropriations in the revenue section and Rs. 2634.38 crores in 83 grants/appropriations in the capital section and excess of Rs. 8.94 crores in 7 grants/appropriations in the revenue section and Rs. 0.31 crore in 3 grants/appropriations in the capital section. The savings in 1979-80 have been analysed in paragraph 26.

24. Supplementary grants/appropriations.—During the year supplementary provision of Rs. 746.52 crores and Rs. 405.61 crores were obtained under 41 and 22 grants in the revenue and capital sections respectively. Supplementary appropriations of Rs. 185.07 crores and Rs. 625.64 crores were also obtained for charged expenditure under 17 and 7 appropriations in the revenue and capital sections respectively.

It would be seen from Appendix V that in 44 grants (20 grants in the revenue section and 24 grants in the capital section), the savings (more than Rs. 5 lakhs in each case) exceeded 20 per cent of the funds; in 22 grants (revenue 6 and capital 16) of these cases, the savings exceeded 30 per cent.

Out of the final saving of Rs. 1479.96 crores (Rs. 545.50 crores in revenue section and Rs. 934.46 crores in capital section) under voted grants, savings in 17 grants, particulars of which are given below, accounted for savings of Rs. 1048.35 crores (Rs. 305.32 crores in revenue section and Rs. 743.03 crores in capital section):

Saving occurred mainly under (i) 'B.6(5)(6)—Gift Paper from Sweden/Norway—Incidental Expenses' (Rs. 1.96 crores) and was due to less incidental expenses following less receipt of gift paper than anticipated, (ii) 'B.6(5)(7)(1)—Non-formal Education Programme for 6—14 age group' (Rs. 7.00 crores) and was due to post-budget decision based on recommendations of National Development Council to convert the scheme into Centrally Sponsored Scheme of the same nomenclature for providing assistance to State Governments in the form of grants-in-aid, and (iii) 'D.2(1)(5)—Rural Functional Literacy Project' (Rs. 12.70 crores) and was mainly due to adjustment during

the year of unspent balance of grants released in previous year and release of grants for this scheme under the heading "Centrally Sponsored Schemes" following post budget decision.

#### Ministry of Finance

(5) 42-Other Expenditure of the Ministry of Finance Rs. 30.39 crores

Saving occurred mainly under 'A.3(2)(1)—Lump sum provision for dearness allowance' (Rs. 35.00 crores) and was due to surrendering of the entire provision for payment of additional instalment of dearness allowance to Central Government servants following provision of funds for the purpose by various Ministries in their respective grants through supplementary demands.

#### Ministry of Health and Family Welfare

(6) 45-Medical and Public Health

Saving occurred mainly under 'D.2(3)(2)(1)-National Malaria Eradication Programme (Rural) Subsidy to States' (Rs. 18.11 crores), D.2(3)(2)(2)—National Malaria Eradication Programme (Rural) Supply of Materials and Equipment' (Rs. 15.35 crores), 'D.2(3)(2)(3)—National Malaria Eradication Programme (Urban) Cash Subsidy' (Rs. 1.68 crores), D.2(3)(2)(4)—National Malaria Eradication Programme (Urban) Supply of Materials and Equipment' (Rs. 2.94 crores), 'D.2(3)(4)—National Leprosy Control Programme: D.2(3) (4)(1)—Subsidy to States' (Rs. 2.00 crores), 'D.2(3)(8)— National T.B. (8) 61-Textiles, Handloom and Handicrafts

Rs. 22.35 crores

Saving occurred mainly under (i) 'C.1(1)(1)(3)—Subsidy to Cotton Corporation of India for Import of Cotton' (Rs. 10.00 crores) and was due to payment of less subsidy to the Corporation following less disposal of cotton stock by it, (ii) 'D.3(10)-Carpet Weaving Training Centre' (Rs. 5.58 crores) and was due to post-budget decision to transfer some schemes to State Government and non-purchase of raw materials, equipment by field formations owing to administrative and technical difficulties and (iii) 'D.4(1)(2)—Grants towards Development of Silk Industries' (Rs. 5.65 crores) and was due to post-budget decision to transfer some schemes to State Governments, non-finalisation of scheme for expansion of silk price stabilisation and opening of new sub-research station and non-approval of estimates for construction of hostel and other functional buildings at its sericulture research station as these required revision for bringing down construction cost.

#### Ministry of Works and Housing

Saving occurred mainly under (i) 'AA.3(1)-Purchase of Fertilizers' (Rs. 31.28 crores) and was mainly due to less import of fertilizers than anticipated and less expenditure on incidental charges, (ii) 'CC.1(1)—Investment in Land Development Corporation/Farmers' Service Societies etc.' (Rs. 2.50 crores) and was mainly due to late finalisation of proposals for central assistance to States and change in the pattern of financing discontinuing equity capital support to State owned Corporations from 1979-80, and (iii) 'EE.1(1)—Loans to Agricultural Refinance Development Corporation for Command Area Development Programme' (Rs. 2.50 crores) and was mainly due to late finalisation of proposals for central assistance to States and change in the pattern of financing from 50 per cent share of the Government of India to 37.5 per cent.

(2) 3-Fisheries Rs. 20.48 crores

Saving occurred mainly under (i) 'BB.2(1)—Shipping Development—Fund Committee—Assistance for acquisition of fishing trawlers' (Rs. 5.00 crores) and was due to non-release of loans to the Committee following delay in completion of guarantee formalities with it by fishing companies for repayment of loan, and (ii) 'BB.2(2)—Loans for Agricultural Refinance Development Corporation-Assistance for Acquisition of Deep Sea Fishing Vessels' (Rs. 14.00 crores) and was due to non-release of loans to the Corporation following delay in finalisation of the scheme.

## Ministry of Commerce, Civil Supplies and Co-operation

(3) 12-Foreign Trade and Export Production

Saving occurred mainly under (i) 'EE.2—Loans to Government of German Democratic Republic: EE.2(1)—
Technical Credits incorporated in Trade Agreements' (Rs. 0.78 crore), (ii) 'EE.3—Loans to Government of Poland: EE.3(1)—

Saying occured mainly under 'BB.2(5)(1)—Investment in National Hydro-Electric Power Corporation of India' (Rs. 95.00 crores) and was due to non-investment in the Corporation following non-transfer of Salal Hydro-Electric Project to the Corporation owing to delay in completion of certain formalities.

#### (5) 30-Coal and Lignite

Rs. 221.23 crores

Saving occurred mainly under (i) 'AA.1(2)—Investment in Coal India Ltd.' (Rs. 26.68 crores), (ii) 'AA.1(6)—Acquisition of Coal Washeries from Hidustan Steel Limited' (Rs. 25.00 crores) and was due to less investment made in the Corporation following slow progress of works on the projects and non-materialisation of transfer of coal washeries to Coal India Limited from Hindustan Steel Limited (iii) 'BB.1(1)—Neyveli Lignite Corporation Limited' (Rs. 15.15 crores) and was mainly due to payment of less loans to the Corporation owing to reduction in its expenditure following re-scheduling of programme for second Mine Cut and Thermal Power Station, and (iv) 'BB.1(2)—Coal India Ltd.' (Rs. 137.99 crores) and was mainly due to payment of less loans to the Corporation following slow progress of works on the projects, improvement in its internal resources and non-transfer of coal washeries from Hindustan Steel Limited.

#### Ministry of Finance

(6) 42-Other Expenditure of the Ministry of Finance

Rs. 42.25 crores

Saving occurred mainly under 'AA.8(2)—Loans to Railway Revenue Reserve Fund' (Rs. 60.84 crores) and was due to non-payment of loans following post-budget changes made in financial arrangements with Railways on the recommendations of Railway Convention Committee.

#### Ministry of Petroleum, Chemicals and Fertilizers

(7) 70-Petroleum and Petro-Chemicals Industries

Rs. 23.29 crores

Saving occurred mainly under 'AA.1(1)—Oil and Natural Gas Commission' (Rs. 56.31 crores) and was due to less expenditure on investment following post-budget decision to maintain debt equity ratio (1:1) by payment of more loans to the Commission, delay in commissioning of Bombay High North, S A and S B platforms, Nhava development and post-ponement of procurement of multipurpose vessel.

#### Ministry of Shipping and Transport

(8) 77-Ports, Light-houses and Shipping

Rs. 51.25 crores

Saving occurred mainly under (i) 'CC.1(2)-Development of Minor Ports: CC.1(2)(1)-Construction of landing facilities and jetties' (Rs. 2.36 crores) and was mainly due to non-receipt of two cranes, non-availability of steel/cement for dry dock and other works, non-sanctioning of certain ports, less purchase of material and stores and delay in purchase of new survey instrument, (ii) 'CC.1(3)-Mangalore Port : CC.1(3)(5)-Floating Crafts' (Rs. 2.89 crores) and was mainly due to delay in purchase of/cancellation of purchase order of certain floating crafts ordered through Directorate General of Supplies and Disposals, (iii) 'CC.1(5)-Kudremukh Iron Ore Project Port facilities' (Rs. 7.28 crores) and was mainly due to less expenditure on establishment and appurtenant works, slow progress of rock dredging work, non-purchase of Mooring Launch and nonadjustment of custom duty, (iv) 'GG-Loans for Ports, Lightand Shipping: GG.1(1)-Loans to Port Trusts: GG.1(1)(1)(2)-Haldia Dock' (Rs. 11.52 crores) and was mainly due to payment of less loans to the Port Trust owing to reduction in entitlement of financial assistance following revision of project estimates, (v) 'GG.1(1)(1)(9)-Salaya Off Shore Terminal' (Rs. 2.35 crores) and was mainly due to payment of less loans following delay in approval of the revised cost estimates of the project, (vi) 'GG.1(1)(1)(10)-Marmugao' (Rs. 4.75 crores) and was mainly due to payment of less loans following reduced entitlement to financial assistance

resulting from commissioning of mechanical ore handling project in December 1978, (vii) 'GG.1(1)(1)(12)-New Tuticorin' (Rs. 2.71 crores) and was mainly due to payment of less loans following slow progress of work of construction of coal jetty and (viii) 'GG.2-Shipping Services: GG.2(1)-Loans to Shipping Development Fund Committee', (Rs. 15.00 crores and was mainly due to payment of less loans to the Committee owing to non-disbursement of assistance by it to shipping companies following their non-fulfilment of stipulated conditions.

(ii) The rest of the saving under voted grants of Rs. 431.61 crores (Rs. 240.18 crores in revenue section and Rs. 191.43 crores in capital section) largely occurred in the revenue and capital sections of the following grants:—

## 27. Expenditure on "New service/New Instrument of Service"

In July 1970, on the recommendations of the Public Accounts Committee, Government had, inter alia, prescribed certain limits for different categories of expenditure beyond which the expenditure constituted "new service" or "new instrument of service" and required prior approval of Parliament. During test-check in audit of the accounts for 1977-78, 1978-79 and 1979-80, the following cases were noticed in which the prescribed limits were exceeded and the expenditure constituted "new service" or "new instrument of service", but no advance from the Contingency Fund was obtained, nor was prior approval of Parliament taken.

## (i) Ministry of Home Affairs

(Grant No. 57-Delhi for 1977-78)

A sum of Rs. 1556.17 lakhs was paid during 1977-78 as grants-in-aid to the Municipal Corporation of Delhi against a provision of Rs. 1334.30 lakhs in the Budget Estimates. The additional payment of Rs. 221.87 lakhs was in excess of the prescribed limit of Rs. 50 lakhs and was met by re-appropriation within the grant.

## (ii) Ministry of Commerce, Civil Supplies and Cooperation (Grant No. 13—Civil Supplies and Cooperation for 1978-79)

The Department of Civil Supplies and Cooperation paid Rs, 57.50 lakhs during 1978-79 as subsidy to the National Agricultural Cooperative Marketing Federation of India Limited (NAFED) against a provision of Rs, 5 lakhs in the Budget Estimates. The additional payment of subsidy of Rs, 52.50 lakhs was stated to be on account of ginger operation in Mizoram and gur operation in other parts of the country, on which NAFED incurred heavy losses during the course of the year. The additional payment of subsidy was in excess of the prescribed limit of Rs, 10 lakhs and was met by re-appropriation within the grant,

# (iii) Ministry of Petroleum, Chemicals and Fertilizers (Grant No. 71—Chemicals and Fertilizers Industries for 1979-80)

The Department of Chemicals and Fertilizers paid Rs, 1204.63 lakhs during 1979-80 as loans to the Hindustan Antibiotics Limited against a provision of Rs. 942.63 lakhs in the Budget Estimates. The increased payment to the company was stated to be for meeting its cash losses resulting from higher costs of inputs without any corresponding upward revision of prices of drugs and formulations of the company. The additional payment of Rs. 262 lakhs was in excess of the prescribed limit of Rs. 200 lakhs and was met by re-appropriation within the grant.

## (iv) Ministry of Commerce, Civil Supplies and Cooperation (Grant No. 12—Foreign Trade and Export Production for 1979-80)

During 1979-80, the Ministry paid grants-in-aid of Rs. 80.66 lakhs to the Trade Fair Authority of India against the budget provision of Rs. 47.81 lakhs; the additional payment of Rs. 32.85 lakhs was in excess of the prescribed limit of Rs. 10 lakhs and was met by re-appropriating funds within the grant.

# (v) Ministry of Steel and Mines (Department of Steel) (Grant No. 79—Department of Steel for 1979-80)

During 1979-80, the Department of Steel paid grants-in-aid of Rs. 90 lakhs and of Rs. 20 lakhs to the National Mineral Development Corporation against corresponding budget provisions of Rs. 68 lakhs and Rs. 3 lakhs respectively. The additional payment of Rs. 22 lakhs and Rs. 17 lakhs exceeded the prescribed limit of Rs. 10 lakhs and were met by re-appropriating funds within the grant.

## (vi) Ministry of Industry (Department of Textiles) (Grant No. 61—Textiles, Handloom and Handicrafts for 1978-79)

During 1978-79, the Ministry of Industry incurred an expenditure of Rs. 207.94 lakhs on certain schemes against the budget provision of Rs. 75.20 lakhs. Out of the additional expenditure of Rs. 132.74 lakhs, Rs. 106.36 lakhs were met by

re-appropriation of funds during the year. The additional expenditure pertained to new schemes relating to the establishment of rural marketing and service centres for village artisans, common facility service centres, etc. and was of the nature of 'new service/new instrument of service'.

## (vii) Ministry of Home Affairs

(Grant No. 53-Delhi for 1979-80)

During 1979-80, Delhi Administration paid grants-in-aid of Rs. 484.11 lakhs to Delhi Development Authority against the budget provision of Rs. 220 lakhs. The additional expenditure (Rs. 264.11 lakhs) exceeded the prescribed limit of Rs. 30 lakhs and was met by re-appropriating funds within the grant.

## 28. Non-implementation of programmes/schemes

During test-check in audit of the accounts for 1977-78. 1978-79 and 1979-80, the following cases were noticed in which non-implementation of programme/scheme resulted in substantial re-appropriations/savings for surrenders within Grants:

## (i) Ministry of Energy

(Grant No. 30-Coal and Lignite)

The Ministry of Energy decided (March 1975) that, for efficient management and operation of washeries, the ownership of the washeries of the Central Coal Washeries Organisation of Hindustan Steel Limited (HSL) should be transferred to Bharat Coking Coal Limited (Now Coal India Limited) which had already been entrusted with the management of washeries. The ownership was to be transferred to Bharat Coking Coal Limited with effect from 1st April 1975; this date was subsequently deferred to 30th October 1976.

Government was to acquire the assets provisionally valued at Rs. 25 crores subject to final agreement and valuation by the HSL. In consideration of the transfer of assets to Government, the HSL was to be considered as having repaid loan to Government to the extent of Rs. 25 crores or whichever figure was

finally arrived at. Further, Government was to invest in the Coal India Limited half the value of assets as equity and half as loan. Accordingly, budget provision of Rs. 25 crores for acquisition of coal washeries and of Rs. 12.50 crores each for investment in and loan to the Coal India Limited was made for the first time in 1977-78, thereafter in 1978-79, 1979-80 and 1980-81. The transfer of ownership had, however, not yet taken place (December 1980). The budget provision of Rs. 50 crores, which was thus continued to be made in each of the years 1977-78, 1978-79 and 1979-80 without settling the formalities between Department of Steel and Department of Coal, had been re-appropriated for other purposes within the grant or surrendered.

It was proposed to extend in 1979-80 the scheme of strengthening of the planning machinery at the State level to the strengthening of the planning machinery at the district level for block level planning. A budget provision of Rs. 150 lakhs was made (part of Rs. 275.60 lakhs); however, the scheme was dropped on 9th July 1979 and the whole provision alongwith other saving was surrendered in March 1980. Besides, claims amounting to Rs. 81.38 lakhs were not received from the States in time for re-imbursement.

The saving in 1977-78 was 19 per cent, that in 1978-79 78 per cent and that in 1979-80 was 84 per cent. The budget provision, thus made, was not realistic during the three years.
