Certificate of the Comptroller and Auditor General of India

This compilation containing the Finance Accounts of the Government of Uttarakhand for the year ending 31 March 2013 presents the financial position along with accounts of the receipts and disbursements of the Government for the year. These Accounts are presented in two volumes, Volume I contains the consolidated position of the state of finances and Volume II depicts the accounts in detail. The Appropriation Accounts of the Government for the year for Grants and Charged Appropriations are presented in a separate compilation.

The Finance Accounts have been prepared under my supervision in accordance with the requirements of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 read with the provisions of the Uttar Pradesh Re-organization Act, 2000 and have been compiled from the vouchers, challans and initial and subsidiary accounts rendered by the treasuries, offices, and departments responsible for the keeping of such accounts functioning under the control of the Government of Uttarakhand and the statements received from the Reserve Bank of India. Statement No. 9, explanatory note No. 2 to Statement No.11 and Appendix No. X and XII in this compilation have been prepared directly from the information received from the Government of Uttarakhand /Corporations /Companies/ Societies who are responsible to ensure the correctness of such information.

The treasuries, offices, and/or departments functioning under the control of the Government of Uttarakhand are primarily responsible for preparation and correctness of the initial and subsidiary accounts as well as ensuring the regularity of transactions in accordance with the applicable laws, standards, rules and regulations relating to such accounts and transactions. I am responsible for preparation and submission of Annual Accounts to the State Legislature. My responsibility for the preparation of accounts is discharged through the office of the Principal Accountant General (A&E). The audit of these accounts is independently conducted through the office of the Accountant General (Audit) in accordance with the requirements of Articles 149 and 151 of the Constitution of India and the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971, for expressing an opinion on these Accounts based on the results of such audit.

These offices are independent organizations with distinct cadres, separate reporting lines and management structure.

The audit was conducted in accordance with the Auditing Standards generally accepted in India. These Standards require that we plan and perform the audit to obtain reasonable assurance that the accounts are free from material misstatement. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements.

On the basis of the information and explanations that my officers required and have obtained, and according to the best of my information as a result of test audit of the accounts and on consideration of explanations given, I certify that, to the best of my knowledge and belief, the Finance Accounts read with the explanatory 'Notes to Accounts' give a true and fair view of the financial position, and the receipts and disbursements of the Government of Uttarakhand for the year 2012-13.

Points of interest arising from study of these accounts as well as test audit conducted during the year or earlier years are contained in my Reports on the Government of Uttarakhand being presented separately for the year ended 31 March 2013.

Guide to the Finance Accounts

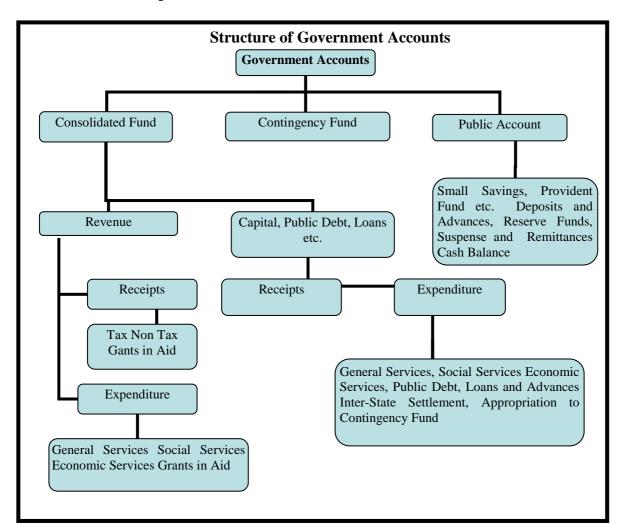
A. Broad overview of the Structure of Government Accounts

1. The Accounts of the Government are kept in three parts:

Part I: The Consolidated Fund: All Receipts and Expenditure on Revenue and Capital Account, Public Debt and Loans & Advances forms the Consolidated Fund of the State.

Part II: The Contingency Fund: Legislature may by law establish a Contingency Fund which is in the nature of an imprest. The Fund is placed at the disposal of the Governor to enable advances to be made for meeting unforeseen expenditure pending authorisation of such expenditure by the State Legislature. The fund is recouped by debiting the expenditure to the concerned functional major head in the Consolidated Fund of the State.

Part III: The Public Account: All other public moneys received by or on behalf of the Government are credited to the Public Account. The expenditure out of this account is not subject to the vote of the Legislature. In respect of the receipts into this account, the Government acts as banker trustee. Transactions relating a or to Debt (other than public debt in Part I), Deposits, Advances, Reserve Funds, Remittances and Suspense form the Public Account.

2. DIVISIONS, SECTIONS, SECTORS etc

The two main divisions of the Accounts in the Consolidated fund are, as depicted in A.1.1 on previous page, 'Revenue and 'Capital, Public Debt, Loans etc.' which are divided into sections 'Receipts' and 'Expenditure'. Within each of the Divisions and Sections of the Consolidated Fund the transactions on the expenditure side are grouped into Sectors such as, "General Services", "Social Services", "Economic Services", under which specific functions or services shall be grouped. The Sectors are sub-divided into subsectors/Major heads of account. Major heads correspond to functions and are further divided into sub major heads (sub functions) and minor heads (programmes) which are depicted in Volume 2 of the Finance Accounts. The classification below minor heads of account i.e. subheads (schemes) and detailed and object heads(objects of expenditure) are not depicted in the Finance Accounts (minor exceptions exist), though some details are included in the appendices.

B. WHAT DO THE STATEMENTS CONTAIN

The Finance Accounts have been divided into two volumes. Volume 1 presents the financial statements of the Government in the form of commonly understood summarised form while the details are presented in Volume 2.

Volume 1 contains the Certificate of the Comptroller and Auditor General of India, four summary statements as given below and Notes to Accounts including accounting policy.

- 1. **Statement of financial position**: Cumulative figures of assets and liabilities of the Government, as they stand at the end of the year, are depicted in the statement. The assets are largely financial assets with the figures for progressive capital expenditure denoting physical assets of the Government. Assets, as per the accounting policy, are depicted at historical cost.
- 2. **Statement of receipts and disbursement**: This is a summarised statement showing all receipts and disbursements of the Government during the year in all the three parts in which Government account is kept, namely, the consolidated fund, contingency fund and public account. Further within the consolidated fund, receipts and expenditure on revenue and capital account are depicted distinctly. The fiscal parameters of the Government, i.e. the primary, revenue and fiscal deficit are calculated on the operations of the consolidated fund of the State. Hence the following two statements give the operations of the consolidated fund in a summarised form.
- 3. **Statement of receipts (consolidated fund):** This statement comprises revenue and capital receipts and receipts from borrowings of the Government consisting of loans from the GOI, other institutions, market loans raised by the Government and recoveries on account of loans and advances made by the Government.
- 4. **Statement of expenditure (Consolidated Fund):** This statement not only gives expenditure by function (activity) but also summarises expenditure by nature of activity (objects of expenditure).

In addition the volume comprises an appendix, Appendix 1, which is an alternate depiction of receipts and disbursements of the Government in the form of a cash flow statement.

The second volume comprises three parts. The first part contains six statements as given below:

- 5. **Statement of progressive capital expenditure**: This statement details progressive capital expenditure by functions, the aggregate of which is depicted in statement 1.
- 6. **Statement of Borrowings and other liabilities**: Borrowings of the Government comprise market loans raised by it (internal debt) and Loans and Advances received from the GOI. Both these together form the public debt of the State Government. In addition, this summary statement depicts 'other liabilities' which are the balances under various sectors in the public account. In respect of the latter, the Government as a trustee or custodian of the funds, hence these constitute liabilities of the Government. The statement also contains a note on service of debt, i.e a note on the quantum of net interest charges met from revenue receipts.
- 7. **Statement of Loans given by the Government**: The loans and advances given by the State Government are depicted in statement 1 and recoveries, disbursements feature in statement 2,3 and 4. Here, loans and advances are summarised sector and loanee group wise. This is followed by a note on the recoveries in arrear in respect of loans, the details of which are maintained by the AG office as also by the State departments.
- 8. **Statement of Grants in aid given by the State Government**, organised by grantee institutions group wise. It includes a note on grants given in kind also.
- 9. Statement of Guarantees given by the Government: Guarantees given by the State

Guarantees for repayment of loans, etc. raised by Statutory Corporations, Government Companies, Local Bodies and Other institutions during the year and sums guaranteed outstanding, at the end of the year, are presented in this statement.

10. **Statement of Voted and Charged Expenditure**: This statement presents details of voted and charged expenditure of the Government.

Part II Volume 2: This part contains **9 statements** presenting details of transactions **by minor head** corresponding to statements in Volume 1 and Part 1 of Volume 2.

- 11. **Detailed Statement of Revenue and Capital Receipts by minor heads**: This statement presents the revenue and capital receipts of the Government in detail.
- 12. **Detailed Statement of Revenue Expenditure by minor heads:** This statement presents the details of revenue expenditure of the Government in detail. Non Plan and Plan figures are depicted separately and a comparison with the figures for the previous year are available.
- 13. **Detailed Statement of Capital Expenditure by minor heads**: This statement presents the details of capital expenditure of the Government in detail. Non Plan and Plan figures are depicted separately and a comparison with the figures for the previous year are available. Cumulative capital expenditure upto the end of the year is also depicted.

- 14. **Detailed Statement of Investments of the Government**: The position of Government Investments in the share Capital and debentures of different concerns is depicted in this statement for the current and previous year. Details include type of shares held, face value, dividend received etc.
- 15. **Detailed statement of borrowings and other Liabilities**: details of borrowings (market loans raised by the Government and loans etc. from GOI) by Minor Heads, the maturity and repayment profile of all loans is provided in this statement. This is the detailed statement corresponding to statement 6 in part I volume 2.
- 16 **Detailed Statement on Loans and Advances given by the Government**: The details of loans and advances given by the Government, the changes in loan balances, loans written off, interest received on loans etc. is presented in this statement. It also presents plan loans separately. This is the detailed statement corresponding to statement 7 in Part 1 Volume 2.
- 17 Detailed Statement on Sources and Application of funds for expenditure other than revenue account: The capital and other expenditure (other than on revenue account) and the sources of fund for the expenditure is depicted in this statement.
- 18 **Detailed Statement on Contingency Fund and other Public Account transactions**: The statement shows changes in contingency fund during the year, the appropriations to the fund, expenditure, amount recouped etc. It also depicts the transactions in public account in detail.
- 19 **Statement showing details of earmarked balances**: This statement shows the details of investment out of reserve funds in Public Account.

Part III Volume 2 contains appendices on salaries, subsidies, grants-in-aid scheme wise and institution wise, details of externally aided projects, scheme wise expenditure in respect of major Central Schemes and State Plan Schemes etc. These details are present in the accounts at sub head level or below (i.e. below minor head levels) and so are not depicted in the Finance Accounts. A detailed list may be referred to in the index in Volume 1 or 2. The Statements read with the appendices give a complete picture of the state of finances prevailing in the State Government.

D. Book adjustments:

Certain transactions are in the nature of book adjustments and do not represent actual cash transaction, as mentioned below. The specific details are mentioned as 'Notes to Accounts' and as footnotes in the relevant statements.

(i) Adjustment of all deductions (GPF, recoveries of advances given etc) from salaries by debiting functional major heads (department concerned) by book adjustment to revenue receipt (e.g. deductions other than GPF)/Public Account (e.g. GPF)

(ii) Creation of funds/adjustment of contribution to Funds in Public Account by debit to Consolidated Fund e.g. Calamity Relief Fund, Reserve Funds, Sinking Fund etc.

(iii) Crediting of deposit heads of accounts in public account by debit to Consolidated Fund.

(iv) Annual adjustment of interest on GPF and State Government Group Insurance Scheme where interest on General Provident Fund of State Government is adjusted by debiting 2049-Interest and crediting 8009-General Provident Fund.

(v) Certain adjustments such as adjustment of Debt waiver scheme granted by the Government of India in accordance with the recommendation of Finance Commission. It affects both revenue receipts and public debt heads where central loans are written off by crediting 0075-Misc. General Services by contra entry in the Major Head 6004-Loans and Advances from the Central Government.

NOTES TO ACCOUNTS

1. Summary of significant accounting policies:

(i) Entity and Accounting Period: These accounts present the transactions of the Government of Uttarakhand for the period 1 April 2012 to 31 March 2013. The accounts of receipts and expenditure of the Government of Uttarakhand have been compiled based on the initial accounts rendered by the District Treasuries, Public Works, Forest Divisions and Advices of the Reserve Bank of India. Delays in monthly rendition were negligible, and no accounts have been excluded at the end of the year.

(ii) **Basis of Accounting:** With the exception of some book adjustments (Annexure A) the accounts represent the actual cash receipts and disbursements during the account period. Physical Assets and Financial Assets such as investments etc., are shown at historical cost i.e., the value at the year of acquisition/ purchase. Physical assets are not depreciated or amortized. Losses of physical assets at the end of their life are also not expensed or recognized.

The pension liability of the Government, i.e., the liability towards payment of retirement benefits for the past and the present service of its employees is not included in the accounts. However, the retirement benefits disbursed during the accounts period have been reflected in the accounts (Statement 12).

(iii) Currency in which Accounts are kept: The accounts of Government are maintained in Indian Rupees.

(iv) Form of Accounts: Under Article 150 of the Constitution, the accounts of the Union and of the States are kept in such form as the President may, on the advice of the Comptroller and Auditor General, prescribe. The word "form" used in Article 150 has a comprehensive meaning so as to include the prescription not only of the broad form in which the accounts are to be kept, but also the basis for selecting appropriate heads under which the transactions are to be classified.

(v) Classification between Revenue and Capital: Revenue expenditure is recurring in nature and is intended to be met from revenue receipts. Capital Expenditure is defined as expenditure incurred with the object of increasing concrete assets of a material and permanent character or of reducing permanent liabilities. Expenditure on Grants-in-Aid is recorded as revenue expenditure in the books of the grantor and as revenue receipt in the books of the recipient.

The powers of the Comptroller and Auditor General of India under Article 150 of the Constitution to render advice on the form of accounts cannot be exercised by the States. The Government of Uttarakhand, however, opened a separate Object Head for allotment of grants for creation of Capital assets under 7 Major Heads in the Capital section without the advice of the Principal Accountant General (A&E), to whom this power has been delegated by the Comptroller and Auditor General of India. This also contravened the Indian Government Accounting Standards (IGAS) 2, notified by the Government of India, wherein it has been stated that, expenditure on Grants-in-Aid

for the purpose of creating assets shall not, except in cases specifically authorized by the President on the advice of the Comptroller and Auditor General of India, be debited to a capital head of account in the financial statements of the Government. During 2012-13, the Government of Uttarakhand booked grants-in-aid of ₹ 433.07 crore on creation of capital assets to the Capital head, inflating the Revenue Surplus to this extent.

One of the requirements of IGAS-2 is depiction of Grants-in-Aid in kind, regarding which, no information has been given by the State Government.

2. Status on inclusion of Statements/ information recommended by the Twelfth Finance Commission

The following information, required by the Twelfth Finance Commission, has not been included in the Finance Accounts for the reasons given below:

- a. The information on Committed Liabilities could not be included as an appendix in the Finance Accounts, for want of information from the State Government.
- b. The item 'salaries' in Statement 2 of Appendix II represents salaries of the State sector only, since the salaries of employees of Panchayati Raj Institutions are not captured in the accounts separately.
- c. Only details of explicit subsidy are given in Appendix III.
- d. Appendix XI on maintenance expenditure does not depict the salary component, as it is not captured in the accounts.

3. Quality of Accounts

(i) Bookings under Minor Head 800 'Other Receipts' and 'Other Expenditure': Minor Heads 800-'Other Expenditure' and 'Other Receipts' are intended to be operated only when the appropriate minor head has not been provided in the accounts. Routine operation of Minor Heads 800 is to be discouraged, since it renders the accounts opaque. ₹ 858.18 crore under thirty nine Major Heads of account, constituting 6.15 per cent of the total revenue expenditure recorded under the respective Major Heads was classified under the Minor Head 'Other Expenditure' in the Revenue account. Similarly, ₹ 2462.87 crore under thirty eight Major Heads of account, constituting 15.64 per cent of the total receipts recorded under the respective Major Heads, was classified under the Minor Head 'Other Receipts'. Instances where a substantial proportion (50 per cent or more) of the receipts and expenditure were classified under Minor Head 800 are listed in Annexure B (i) and B (ii)

(ii) Reconciliation of Receipts and Expenditure

Para 109 of the Uttarakhand Budget Manual 2012 requires all the Controlling Officers to reconcile the Receipts and Expenditure of the Government with the figures of the Principal Accountant General (A&E). Such reconciliation has been completed in respect of 55 out of the 62 Chief Controlling Officers (89 per cent) for a value of $\overline{\mathbf{x}}$ 76,35.71 crore (44 per cent of expenditure) against the total expenditure of the Government for 2012-13 amounting to $\overline{\mathbf{x}}$ 1,75,02.31 crore (both revenue and capital).

Similarly, 32 out of 48 CCOs (67 per cent) have reconciled receipts of ₹ 86,99.30 crore (55 per cent of total revenue receipt of ₹ 1,57,47.22 crore). Non reconciliation affects the accuracy and completeness of accounts.

(iii) Unadjusted Abstract Contingency (AC) Bills:

Drawing and Disbursing Officers are authorized to draw sums of money by preparing Abstract Contingency (AC) bills by debiting Service Heads, and they are required to present Detailed Contingency (DC) bills (vouchers in support of final expenditure) in all these cases within thirty days. As at the end of March 2013, 269 DC bills amounting to ₹ 30.43 crore had not been received in the office of the Principal Accountant General (A&E). Prolonged non-submission of supporting DC bills render the expenditure under AC bills opaque. The position of the outstanding AC bills is given below.

Out of ₹ 3.68 crore drawn against AC bills in 2012-13, AC bills amounting to ₹ 2.26 crores were drawn in March 2013 alone. Significant expenditure against AC bills in March indicates that the drawal was primarily to exhaust the budget, and reveals inadequate budgetary control.

(iv) Utilization Certificates (UCs) for Grants-in-Aid: The State Government gives Grants-in-Aid to various bodies for various purposes and schemes. In certain cases, the sanctions may stipulate that Utilization Certificates (UCs) of the released grants are to be forwarded to the Principal Accountant General (A&E) and require the Principal Accountant General to ensure receipt of such UCs. In the absence of UCs the Principal Accountant General is unable to draw the assurance that the Grants-in-Aid have been utilized for the intended purposes. Details are given below

(v) Cash Balance: There is a net difference of \gtrless 11.27 crore (Dr.) as on 31 March 2013 between the Cash balance worked out by the Principal Accountant General (A&E) and reported by the Reserve Bank of India (RBI). This difference has subsequently been reduced to a net balance of \gtrless 0.14 crore (Cr), which is under reconciliation.

4. Other items

(i) Liabilities on Retirement Benefits

The expenditure on pension and other retirement benefits during the year to State Government employees recruited on or before 30 September 2005 was ₹ 13,65.69 crore (9.78 per cent of the total Revenue Expenditure). The apportionment of the pensionary dues between the State Governments of Uttar Pradesh and Uttarakhand from 2000-2010, in terms of the Uttar Pradesh Reorganisation Act, 2000, has been completed. During 2012-13, the State of Uttarakhand received ₹ 1045.98 crore from the State of Uttar Pradesh in part payment of its pensionary dues till 2009-10. Though this has been booked under the revenue receipts of 2012-13, these pertain to expenditure of previous years, and its effect on the Revenue Surplus of 2012-13 is to be appropriately discounted. The apportionment of pensionary dues for 2010-11 has been referred to the Government of India.

State Government employees recruited on or after 1 October 2005 are covered under the New Pension Scheme, 2005, which is a defined contribution scheme. In terms of the Scheme, the employee contributes 10 per cent of his basic pay and dearness allowance, which is matched by the State Government, and the entire amount is transferred to the designated fund manager through the National Securities Depository Limited (NSDL)/ Trustee Bank. The actual amount payable by employees and the matching Government contribution has not been estimated. However, as per the information furnished by the State Government, employees' and employer's contribution of ₹172.45 crore has been booked under MH-0071-117-Defined Contribution Pension Scheme in the year 2012-13. Out of this, ₹171.62 crore has been transferred to NSDL. Uncollected, unmatched and untransferred amounts, with accrued interest, represent outstanding liabilities under the Scheme.

(ii) Funds kept outside Government Accounts:

The State Government provides funds to State/ District level autonomous bodies and authorities, societies, non-governmental organizations, etc., for implementation of centrally sponsored schemes (State's share) and State Schemes. Since the funds are generally not being spent fully by the implementing agencies in the same financial year, there remain unspent balances in the bank accounts of these implementing agencies. The aggregate amount of the unspent balances in the accounts of the implementing agencies kept outside Government accounts (in bank accounts) is not known. The Government expenditure as reflected in the Finance Accounts to that extent is, therefore, not final.

In addition, during the year, the Government of India made direct transfers amounting to ₹ 1567.57 crore to implementing agencies in the State instead of routing them through the State Government. Though there is no assurance that complete details of such transfers are available, details of such fund transfer as captured from the Central Plan Schemes Monitoring System (CPSMS) portal of the Controller General of Accounts are given in Appendix-VII.

(iii) Suspense Balances

The Finance Accounts reflect the net balances under Suspense and Remittances Heads. The outstanding balance under these heads is worked out by aggregating the outstanding debit and credit balances separately under various heads. The position of gross figures under some of the major Suspense Heads (under Major Head 8658) for the last three years is given in Annexure C.

(iv) Guarantees:

Guarantees reported in Statement 9 are on the basis of the information received from the State Government, which is the authority for issuing such guarantees. The information contained in the Statement is incomplete, as the State Government has provided only limited information on outstanding guarantees; information regarding maximum amount of guarantees, additions/ deletions/ invoked/ discharged/ not discharged during the year, guarantee commission received etc., has not been made available.

(v) Loans and Investments

Details of Loans and Investments, for which detailed accounts are kept by the State Government departments, have been included to the extent furnished by the State Government. State Government departments have not furnished complete details of loans and the recoveries that are in arrears. Consequently, the requirements of IGAS 3 have not been fully met in these accounts.

Similarly, the State Government has not made available/ confirmed the information on investments made by them. Consequently, the information contained in the Finance Accounts are primarily based on limited information on Government investments depicted under minor head "190- Investments in Public Sector and other Undertakings" of the Capital Major Heads, which are captured from vouchers by the Principal Accountant General (A&E)

(vi) Reserve Funds

Details of Book adjustments carried out by the Principal Accountant General (A&E) on the contribution of State Government to various Reserve/Deposit Funds and their utilization are indicated in Annexure-A. Detailed information on reserve funds and the investment from the earmarked funds is available in Statements 18 & 19 respectively.

a. Consolidated Sinking Fund: In terms of the recommendations of the Twelfth Finance Commission, the State Government of Uttarakhand constituted a revised scheme for constitution and administration of the Consolidated Sinking Fund in 2006 for redeeming its outstanding liabilities (internal debt and public account liabilities of

the State Government). The Fund is administered by the Reserve Bank of India (RBI) subject to such directions/ instructions as the government may issue from time to time. The Government pays to the RBI a commission at the rate of 1/8 per cent of 1 per cent on the turnover of the Fund or at the rate to be mutually decided from time to time. In the year 2012-13, an amount of ₹ 150.00 crore has been appropriated from the Consolidated Fund of the State to the Sinking Fund which is more than the requirement of 0.5 per cent (₹ 128 crore) of outstanding liabilities as on 31 March 2013 (₹ 25539.88 crore). The total accumulations at the end of 2012-13 stood at ₹ 1128.00 crore. Out of the total accumulations in the Fund, an amount of ₹ 1053.62 crore has been invested by the Reserve Bank of India.

b. Guarantee Redemption Fund: The Government of Uttarakhand has set up a Guarantee Redemption Fund in 2006-07 as recommended by the Twelfth Finance Commission. The entire contribution of $\overline{\mathbf{x}}$ 25.00 crore as on 31 March 2013 with accumulated interest of $\overline{\mathbf{x}}$ 12.38 crore lying in the Fund has been invested in Government Securities by the RBI. No amount has been invoked in 2012-13 towards guarantees. In the year 2012-13, against outstanding guarantees of $\overline{\mathbf{x}}$ 1570.15 crore, the State Government did not make any contribution to the Fund.

c. State Disaster Response Fund (SDRF): The erstwhile Calamity Relief Fund has been replaced by the State Disaster Response Fund (SDRF) as recommended by the Thirteenth Finance Commission. In terms of the guidelines of the Fund, the Central and Special Category State Governments like Uttarakhand are required to contribute to the Fund in the proportion of 90:10.

The balance in the Fund at the beginning of 2012-13 was ₹ 41.72 crore. During 2012-13, an amount of ₹ 129.72 crore (90 per cent Central share to the tune of ₹ 116.75 crore and 10 per cent State share to the tune of ₹ 12.97 crore) has been appropriated from the Consolidated Fund to the SDRF, while an amount of ₹ 134.59 crore has been expended from the Fund leaving a credit balance of ₹ 36.85 crore.

(vii) Contingency Fund

The Corpus of the Contingency Fund of the State Government is ₹ 2,00. 00 crore. Out of this, an amount of ₹ 97.15 crore (₹ 61.62 crore on Capital and ₹ 35.53 on Revenue heads of account) remained unrecouped at the end of the year. This has resulted in overstatement of Revenue Surplus by ₹ 35.53 crore and understatement of Fiscal Deficit by ₹ 97.15 crore.

(viii) Rush of Expenditure

Out of total Capital expenditure of ₹ 3542.09 crore, an amount of ₹ 1827.55 crore constituting about 52 per cent of the Capital Expenditure of and out of the Revenue expenditure of ₹ 13462.61 crore, an amount of ₹ 1867.87 crore constituting about 14 per cent of Revenue Expenditure was expended in the month of March. ₹ 245.56 crore and ₹ 230.21 crore constituting 1.75 per cent and 6.49 per cent of Revenue and Capital expenditure respectively was spent on 31 March 2013. Also, an amount of ₹ 214.95 crore constituting about 6 per cent of the total expenditure under Revenue and

Capital Account was transferred to the Public Account in March. Expenditure/transfers on the last day of March indicate that these were done primarily for exhausting the budget and reveal inadequate budget control.

(ix) Uttarakhand Fiscal Responsibility and Budget Management Act, 2005:

The Government of Uttarakhand has enacted the Fiscal Responsibility and Budget Management (FRBM) Act, 2005. Achievements during the year 2012-13 against targets laid down in the Act and rules framed there under, were as follows:-

APPENDIX- I CASH FLOW STATEMENT

Explanatory Notes

(a) Cash and Cash Equivalents:

Cash and cash equivalents consist of cash in treasuries and deposit with Reserve Bank of India and other Banks and Remittances in transit, as stated above. The balance under the head 'Deposits with Reserve Bank' {a (2) above } depicts the combined balance of the Consolidated Fund, Contingency Fund and the Public Account at the end of the year. To arrive at the overall cash position, the cash balances with treasuries, departments and investments out of the cash balances/reserve funds etc. are added to the balance in 'Deposits with RBI'.

(b) Daily Cash Balance:

Under an agreement with the Reserve Bank of India, the State Government has to maintain a minimum cash balance of \gtrless 0.16 crore with the Bank. If the balance falls below the agreed minimum on any day, the deficiency is made good by taking ordinary and special ways and means advances/overdrafts from time to time.

APPENDIX- I CASH FLOW STATEMENT

For arriving at the daily cash balance¹ for the purpose of grant of Ways and Means advances/Overdraft, the RBI evaluates the holdings of the 14 day treasury bills along with the transactions reported (at RBI counters, Inter-Government transactions and Treasury transactions reported by the agency banks) for the day. To the cash balance so arrived, the maturity of 14 day Treasury Bills if any, is added and excess balance, if any, after maintaining the minimum cash balance is reinvested in Treasury Bills. If the net cash balance arrived at results in less than the minimum cash balance or a credit balance and if there are no 14 day treasury bills maturing on that day, RBI rediscounts the holdings of the 14 day Treasury Bills and makes good the shortfall. If there is no holding of 14 day Treasury Bills on that day the State Government applies for Ways and Means Advances/Special Ways and Means Advances/ Over Draft.

(c) Ways and Means Advances:

The limit for ordinary ways and means advances to the State Government was \gtrless 1,45.00 crore with effect from 1 April 2009 The Bank has also agreed to give special ways and means advances against the pledge of Government Securities. The limit of Special Ways and Means Advances is revised by the Bank from time to time. During the year 2012-13, the limit of Special Ways and Means Advances varied from \gtrless 1,23.89 crore to \gtrless 149.52 crore.

Explanatory Notes to Statement 6

1. Amortisation arrangements-Government of Uttarakhand has created a "Consolidated Sinking Fund" for amortization of loans raised by it in the open market and other outstanding liabilities. The fund has been built up by contribution from revenue (Consolidated Fund) and interest accrued on the investments made out of the Fund. The Government shall contribute and continue to contribute an amount equivalent to a minimum of 0.5 *per cent* of the outstanding liabilities as at the end of the previous year. This Fund is to be utilized as an amortization Fund for redemption of the outstanding liabilities of the Government. The Fund shall not be utilized for any purpose other than redemption of outstanding liabilities of the Government. The total amount as outstanding liabilities stood at ₹ 2,55,39.88 crore as on 31 March 2013.

The total balance in the "Consolidated Sinking Fund" as on 31 March 2013, was \gtrless 11,28.00 crore. Out of this, an amount of \gtrless 10,53.62 crore was invested in the Government of India Securities, leaving a net balance of \gtrless 74.38 crore in the Fund.

2. Loans from Small Saving Fund – Loans out of the collection in the 'Small Savings Schemes' and 'Public Provident Fund' in the Post Offices are being shared between the State Government and the Central Government in the ratio of 3:1. A separate fund viz. 'National Small Savings Fund' was created in 1999-2000 for the purpose of release of loans out of Small Savings collections. The loans received during 2012-13 amounted to ₹ 7,39.38 crore and ₹ 2,34.10 crore was repaid during the year. The balance outstanding at the end of the year was ₹ 74,03.60 crore which was 28.99 per cent of the total Liabilities of the State Government as on 31 March 2013.

3. Market Loans- These are long term loans raised in the market having a currency of more than twelve months. During the year 2012-13 three loans 8.93 *per cent* Govt. Stock 2022 for \gtrless 1,50.00 crore, 9.01 *per cent* Govt. Stock 2022 for \gtrless 5,00.00 crore and 8.67 *per cent* Govt. Stock 2023 for \gtrless 11,00.00 crore were raised in the months of December 2012, December 2012, and February 2013 respectively.

4. Loans and Advances from GOI – The borrowings from the Government of India increased by ₹ 6.08 crore from ₹ 4,55.46 crore at the end of 2011-12 to ₹ 4,61.54 crore at the end of 2012-13.

5. Service of debt

To this the balances under Public Debt, Loans and Advances, Small Savings, Provident Funds, Reserve Funds Deposits and Advances, Suspense and Miscellaneous (Other than Miscellaneous Government Account), Remittances and Contingency Fund, etc. are added and the closing cash balance at the end of the year is to be worked out and proved. The other headings in the summary take into account the balances under all accounts heads in Government books in regard to which Government has a liability to repay the money received or has a claim to recover the amounts paid and also of account opened in the books for adjustment of remittance transactions.

It must be understood that these balances can not be regarded as a complete record of the financial positon of the Government as it does not take into account all the physical assets of the State, such as lands, buildings, communication, etc. nor any accured dues or outstanding liabilitaties which are not brought to account under the cash basis of accounting followed by Government.
