RECORD ISSUE

Although the information leading to the seizure is required to be re-corded by a customs officer, in cases where the information calls for in-stant action, the prior recording of the information and the informer's

the information and identity is not necessary. This makes it possible for unscru-pulous officials to take advantage of the secrecy regarding the identity of the secrecy regarding the rethe secrecy regarding the identity of the informers and sanction the re-ward under fictitious names or to persons who really had nothing to do with the seizure, but are willing to collaborate with the officials
